Overbearing nature of proposal, design and appearance, does not meet BE2 in the VALP respecting the design in the local area or SD1 in the Neighbourhood Plan design of sustainable development. WPC also notes the ecology report in relation to bats has not been carried out.

Wendover Parish Council – Objection. Proposed extension is in front of the building line. Contravenes SD1 in the Neighbourhood Plan. Does not fit in with the street scene and is overbearing and overshadowing. The application has already been called in to Committee by Councillor Steve Bowles.

#### 7. CLERK'S REPORT INCLUDING HISTORY AND CORRESPONDENCE

# **Action with Communities in Rural England (ACRE)**

**P20/127** A document that accompanies the Planning White Paper regarding the Rural Analysis of Consultation sets out three measures that would come into operation under the current planning system, before the more radical overhaul of the planning system set out in planning white paper mainly in relation to First Time Housing and Affordable Housing.

#### **Calling in Process**

**P20/128** Since the Unitary Authority was formed the process of objecting to applications has changed. Wendover Parish Council has to "Call In" an application via a District Councillor who will represent the Council at a Committee Meeting. A document has been written to reflect the procedure for the Wendover Parish Council Planning Committee to refer to in the future.

# Changed to Planning System 2020 and changes to the Use Classes Order in England for Different Property Types

**P20/129** In responses to Boris Johnson's comments to Build, Build, Build in 2018, sweeping changes to the Planning Systems mean more types of commercial premises will have total flexibility i.e. retail to cafes/offices. Wider ranges of commercial buildings can change to residential use without the need for a planning application. Builders no longer need a normal planning application to demolish and rebuild vacant and redundant residential and commercial buildings if they are rebuilt as homes. Additional stories on flats and houses will be allowed under permitted development.

# **Consultation Papers on Proposed Planning**

**P20/130** The National Association of Local Councils have requested answers to Changes to the Current Planning System by 17<sup>th</sup> September 2020. The Chairman of Planning, Councillor Sheila Bulpett, completed the questionnaire which was forwarded by the National Association of Local Councils to the Planning Committee for comment before 17<sup>th</sup> September 2020. The questionnaire related to Standards Method of Assessing House Numbers in Strategic Plans, Delivering First Homes, Supporting Small and Medium sized Developers and the Extension of the Permission in Principle Consent Regime. A further two questionnaires are due by 15<sup>th</sup> and 16<sup>th</sup> October 2020.

# The Royal Town Planning Institute - The Planning White Paper On A Single Page

**P20/131** The RTPI had sent through a useful view at a glance Planning for the Future document, The Planning White Paper was on an A4 single page.

**20/132** Councillor Sheila Bulpett wrote a letter to Councillor Peter Strachan expressing Wendover Parish Council's disappointment that the application had been approved as they had not been made aware of the latest date an application could be "called in".

The application was still approved despite objections from Wendover Parish Council and many others. In the white paper on the new planning system proposed by central government, Localism was of great importance including the role of Parish and Town Councils. Wendover Parish Council felt the new process to call in via a Bucks Councillor totally undercuts and disenfranchises the local Parish Council and asked for the new process to be reviewed.
