#### 7. CLERK'S REPORT INCLUDING HISTORY AND CORRESPONDENCE

#### Changes to Planning for Parish Councils under new Bucks Unitary Authority

**P20/035** On 21<sup>st</sup> May an article was printed in the Bucks Herald stating that key decisions regarding planning applications could no longer be called in by Parish and Town Councils meaning that it would be harder for Parishes and Town Councils to have an effective say on developments within their boundaries. The Planning Clerk Jane Ellis was asked to contact Parish Support at Bucks Council and was advised that the public/consultee process would not be changing along with the online support provided to Parishes. In future a Town or Parish Council would need to make a request to "call in the app" to a Councillor at Bucks Council for further scrutiny.

#### **Small Development of Houses on Village Gate Site**

**P20/036** An email had been received from the Cordage Group who have recently purchased the Village Gate Site stating they proposed to demolish it and build 4 detached houses on the plot. The plans were not yet on the portal, but Councillors were already concerned that the development was outside the settlement boundary of Wendover Parish which ends at Halton Lane, as stated in the Wendover Neighbourhood Development Plan and also on the edge of the Area of Outstanding Natural Beauty.

#### **Update from Bucks CC**
