#### Notice of Entry to Carry Out Surveys – EKFB Working on Behalf of HS2

**P20/257** On 6<sup>th</sup> January 2021 Eiffage Kier Ferrovial BAM notified Wendover Parish Council that they would be carrying out survey works at Witchell near the Cricket Ground in relation to the inspection of drains, water sampling and botanical surveys. These would be carried out between 13<sup>th</sup> January 2021 until 21<sup>st</sup> May 2021.

#### Little Missenden Parish Council and HS2 Traffic Issues

**P20/258** The Chairman of Little Missenden Parish Council advised that HS2 have applied to install a roundabout on the A413 dual carriage section outside the village of Little Missenden. The plan is to reduce the carriageway to a single lane and there are concerns that this will cause a huge increase in traffic.
