P20/021 In response to an email Wendover Parish Council sent to Parish Support at Buckinghamshire, a reply was received on 6th May.

Pre- applications are commercially sensitive and are therefore not available to view publicly. Advice is offered to the applicant by the Planning Officer regarding how to overcome any negatives.

Enforcement Cases are confidential and designed to help the applicant find a suitable solution which can sometimes result in a retrospective application.

As the planning application was within the green belt and AONB Buckinghamshire Council advised this would be taken into account when Planning Officers determine the application along with any previous history regarding Enforcement Cases and Pre-Applications.

Buckinghamshire Councils stance is to consider the scheme without prejudice.

If a further report is required in relation to the composting toilets and Environment Health issues the Planning Officer will raise this with the applicant.

HS2 Intermittent Closures of Smalldean
